### **Unfinished Business**

Zoning Administrator Darcia Kelley shared an update regarding the Visser Construction project for the Ride All Drive property. She has talked with both Jay Carll and Visser Construction. Heath Baxter, from Visser, told her that they are in the final stages of the necessary environmental and septic/well studies. Forty-three lots have been tested for septic; all but 3 passed due to the clay level. They may need to rearrange the layout. The next step will be arsenic testing. Both parties are confident that the project will move forward.

A revised ZBA Appeals Application for Variance form was shared. The form now reflects the 8 standards for variance listed in the Zoning Ordinance. A few typos were found that need to be corrected. After some discussion, Commissioner Posekany made a motion to accept the new form as presented with changes to show the correct numbering on the first page and the removal of the word "in" at the top of the second page. Motion supported by Commissioner Klepper.

#### Motion carried.

Denise Johnston and Joe Ryske were present to discuss her request to abandon an undeveloped road bisecting parcels off Burgess Lake Road. She has the 7 signatures required, but some residents have concerns about whether it will remain a right of passage. It was suggested that the easement for the road proposed for abandonment be transferred to the road currently being used. Denise will be talking more with the Road Commission to determine next steps.
